#### **Funeral Directors Information**

Before the end of Summer 2017 we would like to hold a Forum to give you the chance to discuss any concerns or issues you have and to go over any of our new protocols. But below are a few updates that we would like to share with you.

#### **Candles in the Chapel**

A short while ago the previous manager stopped the use of real candles from the chapel. We would now like to change this to the use of contained candles. i.e. candles that are surrounded by glass or metal. Certain religions use candles in their funeral services and it would be disrespectful to stop them completely. If you are unsure then please ask a member of staff.

#### **Donations box protocol**

Just a reminder that we have a new donation box procedure. If you do not supply your own collection box and wish to use ours then we require 48 hour's notice. We can also not allow you to use any item from the crematorium as a collection box. If you are unsure on any of the protocol then please call or email and we can let you know.

#### **Wesley Music**

Wesley Music will endeavour to supply any items of music required for a funeral service, provided they are currently commercially available and a request has been made at least 48 hours (ideally 72 hours) before the service. As you all already know, we have the Wesley Media system fitted in our chapel. This allows access to a huge library of recorded music; you can view which pieces of music we currently hold in our library through the following link (please note – this library is updated daily with additional music we order) You can order music via:

http://www.wesleymedia.co.uk or you can telephone them on: 01536 314914 Please provide as much detail as possible to ensure that the family receive the exact piece of music that they require.

In addition to the music, Wesley Media also provide us with audio visual recordings such as Webcasts, DVD & CD's (a minimum of 48 hours' notice also required). This can provide an excellent service for families unable to attend the Crematorium on the day.

If the need arises the crematorium staff can order the music for your service from Wesley but we advise that this is done by you or your staff.

#### **Funeral directors and Staff tours**

We have always had an open door policy but we would like to extend this and offer tours to Funeral Directors, arrangers and operatives.
